Gymnastics Team Contract – CARA

Being a part of the WCPA Gymnastics Team is a privilege! Gymnasts must work together as a team in order to build strength and achievement.

The following is the set of Rules and Regulations for the WCPA Team. Please read carefully; sign the bottom portion of the contract and return it to the front desk by August 23, 2011.

Rules and Regulations

- Team is a full year commitment (September – August)
- Gymnasts must attend all classes and practices. In cases of severe illness or injury, a doctor's note will be accepted in lieu of your absences. In case of any other illness or minor injury, you will be expected to attend all classes and practices and sit out to observe.
- Requirements for Team Gymnasts:
Team Gymnasts are required to take the Team Gymnastics classes on Tuesdays and Thursdays beginning the week of August 22, 2011 and running through July 2011. Gymnasts are also required to take a ballet or turns class. Tuition for Team Gymnasts (required classes only) - \$210/mo.
- Members of the Gymnastics Team will be required to participate in group activities outside of class and competition (ie., attend high school and college gymnastic meets, participate in parades and local events, etc.) There may be a minimal cost for some of these activities. The cost is the responsibility of the parent/gymnast.
- No more than one excused absence per month will be allowed. Excused absences included illness, school events, church events, etc. All practices/classes prior to a scheduled activity (ie, meet, parade, etc.) must be attended. If these practices/classes are missed, the gymnast will not be allowed to participate in the scheduled event.
- All absences must be called into the studio prior to the class/practice.
- The gymnast must continue with training and fulfill their obligation to the gym/studio.
- Gymnasts may not train at any other gym/studio.
- Competition season runs May through August. All Team members 7 years and older will compete during this season.

- All Team members will be required to purchase a “Team Leotard” and a “Team Warm-up.” The approximate cost for the team leotard is \$95 and the warm-up suit is \$120.
- All Team members are required to participate in the 2011 Gymnastics Camp held at WCPA during the week of July 25, 2011.
- The cost for the CARA association gymnastic meets and coaches fees will be \$175 per gymnast. This fee is due to the studio by March 15, 2012.
- Team members may also participate in the King Soopers Gift Certificate and GLScrip fundraisers. Money earned from these fundraisers goes directly back to your gymnast (towards monthly tuition or any other noted expense).
- All Team members must maintain a 3.0 GPA. If a student’s grades drop below this point they will be put on probation. They will have four weeks to bring the grades up. Gymnasts will not be able to participate in any performances/meets until their grades are up.
- Conduct: Must be on time to all practices and classes. May not leave early unless you receive special permission. Must be properly dressed for every class (leotards, shorts and bare feet with hair pulled away from face), NO LAYERS OF CLOTHING. You will always conduct yourself in a professional manner. You will not use any foul language, smoke, drink or use any drugs. As a member of Westwoods Center of Performing Arts Gymnastics Team, please conduct yourself morally and ethically in all your affairs. Shannon has the right to terminate any contract and ask you to leave the Team if any of these rules are broken.
- There will be absolutely no “bad-mouthing” or gossiping about any WCPA students or students from other gyms or studios.
